



Declaration

Undertaking :

I, the undersigned hereby solemnly affirm and declare that:

1. I will be governed by and adhere to the Rules & Regulations that may be in force or applicable or are framed from time to time by Surya World and its constituent/affiliate Institution(s), sponsoring body whether by specific order in writing or otherwise.
2. I agree that I shall avail the transport facility for the full semester. If due to any reason I withdraw or don't avail this facility, I shall have no claim whatsoever for refund of fee or otherwise against the Surya World.
3. I understand that the Surya World may provide me transport facility, at its own or through other arrangement, as it may deem fit.
4. I agree that I shall not be entitled to claim this facility as a matter of right.
5. I agree that I shall board the transport vehicle from the assigned boarding point/location only.
6. I understand that Surya World has full authority for inspection of the transport vehicle or any of my personal belongings during transit or otherwise in or outside Surya World at any time.
7. I understand that transport vehicle allotted and various provisions and facilities in the vehicle may vary and change from time to time, as may be decided by Surya World.
8. I agree that I shall carry the transport identity card all the time while being in the transport vehicle and shall be liable to produce the same as and when asked for it by the concerned authorities. I may not be allowed to use the transport facility without a valid a identity card.
9. I agree that the Surya World shall not be liable for any damage, loss, accident, and/or mishappening caused to me while being in the transport vehicle or otherwise.
10. I understand and agree that I shall be liable to pay transport charges/fee for the industrial visits, workshops, practical, training, placement visits etc. or for visiting such other place/events as may be specified by Surya World from time to time, in addition to transport fee for the academic session(s).
11. I agree that if declared ineligible for appearing in any examination of Surya World, on account of shortage of attendance or any reason or if detained as a disciplinary action against me at any time, I shall not avail this facility. Availing of transport facility in the forthcoming term/semester may be allowed only at the sole discretion of the Surya World. The fee once paid will not be refundable.
12. I understand and agree that transport fee and related charges are subject to revision from time to time as may be decided by Surya World.
13. I shall be liable to pay for any damage caused by me to the transport vehicle or provisions and facilities therein either alone or jointly with others and shall also be liable to disciplinary action(s) as may be decided by Surya World.
14. I understand and agree that Surya World reserves right to frame, amend, revoke, repeal and enforce the Rules & Regulations, as and when deemed fit and it shall be my responsibility to keep myself well versed and updated with the Rules & Regulations applicable from time to time and that Surya World shall not be responsible for informing me separately in any manner.
